This Privacy Policy is designed to inform you about Distrilab Particle Technology's collection, use, and dissemination practices regarding data information that you provide by visiting the Distrilab Particle Technology website. This Privacy Policy does not apply to any other data use, collection or dissemination practices, such as data collected offline or through websites other than distrilabparticles.com.

This website provides an opportunity to learn and discover more about Distrilab Particle Technology. This website is specifically directed at our customer base – particle technology scientists, particle sizing – and counting instrument operators, quality control officers, diagnostic test development researchers, life science and biotechnology scientists – and providing them with product information, technical and application related information in order to assist them to accomplish their quality control procedures, applications or research and development projects efficiently and to the highest standards.

How we collect information about you:
